WHEREAS, the City of Dayton wishes to adopt and enter that certain Joinder Agreement attached hereto, dated 3rd January 2023.

RESOLVED that the City of Dayton, Commonwealth of Kentucky, hereby enters and adopts the Joinder Agreement with KDC for participation in the 457 Plan and the 401 (K) Plan for the benefit of its eligible employees; and,

WHEREAS, the Development Agreement encumbered certain real property, which is more fully described in Exhibit "A;" this real estate is now being developed by Velo Riverside, LLC, as multi-family residential property ("the Subject Property").

WHEREAS, the City executed a Warranty Deed to Manhattan Harbour Yacht Club, LLC, on November 17, 2014, encumbering the Subject Property.

WHEREAS, the Velo Riverside, LLC and the City wish to terminate and release rights, duties, privileges, and obligations in both the Development Agreement and Warranty Deed as it relates to the Subject Property.

NOW, THEREFORE, BE IT ORDERED BY THE CITY OF DAYTON, KENTUCKY, AS FOLLOWS:

The City authorizes the Mayor to enter into a Release of Restrictions in the Development Agreement and a Release of Restrictions in the Warranty Deed as it relates to the Subject Property being developed by Velo Riverside, LLC, at the northeast corner of the intersection of Manhattan Boulevard and Mary Ingles Highway in Dayton, Ky.

AN ORDER/RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DAYTON, KENTUCKY, AUTHORIZING THE MAYOR TO EXECUTE AND DELIVER AN OPEN-END LEASEHOLD MORTGAGE AND SECURITY AGREEMENT (WITH LESSOR JOINDER) BY THE CITY OF DAYTON IN FAVOR OF GERMAN AMERICAN BANK, AN INDIANA CORPORATION, AND FURTHER AUTHORIZING ANY OTHER RELATED DOCUMENTS OR ACTIONS AS MAY BE REASONABLY REQUIRED BY THE LENDER TO EFFECTUATE THE LOAN.

WHEREAS, the City of Dayton, Kentucky (the "Issuer" and the "City"), by virtue of the laws of the Commonwealth of Kentucky, including Chapter 103 of the Kentucky Revised Statutes, issued its maximum aggregate principal amount \$10,000,000 City of Dayton, Kentucky, Taxable Industrial Building Revenue Bonds, Series 2021A (the "Series 2021A ,Bonds"), and its maximum aggregate principal amount \$2,000,000 City of Dayton, Kentucky, Taxable Industrial Building Revenue Bonds Series 2021B (the "Series 2021B Bonds") (with the Series 2021A Bonds and the Series 2021B Bonds collectively being referred to herein as the "Bonds"), to provide financing for the acquisition, development, and construction of residential condominium units, together with the development of facilities ancillary thereto to be located within the City of Dayton, Kentucky (the "Project"); and

WHEREAS, the Project was initially leased to River Commons at Manhattan Harbour LLC, a Florida limited liability company (the "Company"), and the Bonds were initially purchased by River Commons at Manhattan Harbour LLC, a Florida limited liability company; and

WHEREAS, since the closing of the transaction on December 29, 2021, the Company has secured additional financing for the Project through a loan (the "Loan") made available to the Company by German American Bank (the "Lender"); and

WHEREAS, to secure repayment of the Loan and the Bonds, the Lender has requested that the City execute a Joinder, in the form currently on file with the City Clerk with such changes as may be approved by the City, to grant the Lender an interest in the real property upon which the Project is located (the "Project Site"); and

WHEREAS, the City has agreed to execute the Joinder provided that Lender's interest is limited to the City's interest in the Project Site, and consistent with Section 103.230 of the Kentucky Revised Statutes, the Bonds and Loan are payable solely from the revenue derived from the Project and will not constitute an indebtedness of the City within the meaning of the Kentucky Constitution.

NOW, THEREFORE, IT HEREBY ORDERED AND RESOLVED BY THE CITY COUNCIL OF DAYTON, KENTUCKY, AS FOLLOWS:

<u>Section 1.</u> The Mayor is authorized to execute the Joinder to Open-End Leasehold Mortgage and Security Agreement (with Lessor Joinder) in favor of the Lender, in the form

currently on file with the City Clerk, with such changes as may be approved by the City, and any related documents or instruments that may be reasonably required by the Lender in furtherance of financing the Project.

Section 2. That except as modified herein, the Bonds will remain in full force and effect.

Section 3. It is hereby found and determined that all formal actions of the City Council concerning and relating to the passage of this Order/Resolution were taken in an open meeting of the City Council, and that all deliberations of this City Council and of any of its committees, if any, that resulted in such formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements of the Kentucky Revised Statutes.

<u>Section 4.</u> That this Order/Resolution will be signed by the Mayor, attested to by the City Clerk/Treasurer, recorded, and be effective upon adoption.
