  - **Second Reading: Ordinance 2023-3** – An Ordinance amending Chapter 110 of the City of Dayton, Kentucky, Code of Ordinances, including the schedule occupational license fees businesses owe to the City based on their total gross receipts.
  - **Second Reading: Ordinance 2023-4** – An Ordinance adding a new section 37.02 and amending section 37.04 of the Dayton Code of Ordinances related to the payment, collection, and enforcement of the City's ad valorem property taxes.
  - **Second Reading: Ordinance 2023-5** – An Ordinance prohibiting the operation of recycling operations and storage of recycling materials in residentially and commercially zoned areas of the City of Dayton.
  - **Second Reading: Ordinance 2023-6** – An Ordinance adding a new section 72.15, titled "Vehicles Carrying Recycling Materials," to the Dayton Code of Ordinances.

  - **Second Reading: Ordinance 2023-8** – An Ordinance amending section 380.08(C)(1) of the Dayton Code of Ordinances related to appeals of Code Enforcement citations.
