Dayton October 2024 Report

Tuesday 10/1/24 visited 1004 4th and left a Notice for a bite investigation. The dog owner is Parker Buschelman dob 8/17/97. Last week his dog ran out of the yard and attacked a dog that lives in Spears court that was being walked on a leash on the sidewalk. The injured dog had to get emergency surgery on his neck for a gaping wound.

Thursday 10/3/24 Checked on a dog at 123 4th. There is a cage on the porch. There was not a dog in the cage when I arrived. I did talk to the owner and he explained he don't use the cage for the dog anymore because she can escape it, so he moved it to the porch. He is looking at throwing it away.

Checked on a dog at 1229 5th for bad skin. The dog is a Chinese Sharpai and they are notorious for having bad skin. I asked the owner to get the dog a rabies vaccine and skin checked at a vet within the next 2 weeks.

Monday 10/7/24 Called to Cottonwood for a dog left tied to a fire hydrant. A resident came out and said she tried to untangle the dog and got bit. He left pinky finger was punctured. I told her to contact her doctor and I would do a bite report and place the dog in quarantine at the shelter.

Received a call that 505 4th left behind 2 cats when they moved. I called the landlord and he said he believes they are not returning. I posted an abandonment notice on the front door and tried the number the landlord had for her, it was disconnected. I will get the cats on the TNR schedule.

Wednesday 10/9/24 TNR black female cat from 809 7th.

TNR buff kitten from 409 Kenton.

Received a facebook message about the dog I picked up on Cottonwood on Monday. The person sent me a picture of the dog and information it use to live at 1609 Chateau Ridge apt. 2. I went to the address and spoke with Nicole. She looked at the picture I had of the dog and said that is her dog Ginger. Her boyfriend said it got loose a couple nights ago with the leash attached. The boyfriends name is Frank Hollingsworth. Gave the shelter the information. I also got a number for Mr. Hollingsworth from the property manager and gave that to the shelter.

Thursday 10/10/24 Made contact with a guy at 224 3rd feeding cats. We will get the cats on the list for TNR.

Got antibiotics for a sick cat that hangs out at Tony's Saloon. Found the owner at 704 Berry and gave him the meds.

Friday 10/11/24 I received an email from Cassie about kittens under a porch at 203 3rd. I put them on the list for TNR.

Tuesday 10/15/24 received a call from a home health nurse that a cat had been injured at 4am and not moving. The cat was at 510 7th the disabled man let it in because it was cold out and he fell on the cat. The vet believes its back was broken because its back feet were very cold. The cat was euthanized. I disposed of the body.

l left another Notice at 1004 4th to try and get ahold of the owner so I can cite him to court for the dog attack.

I received a welfare check on a dog at Spears court apartment 127. The complaint was that the dog reportedly eats its own stool on the puppy pads where it goes to the bathroom. The complainant was worried the dog did not have access to food or water. As soon as I seen the dog I could tell it eats very well. I asked the owner what she fed the dog and she said Little Caesers. She did confirm that the dog eats its stool.

Wednesday 10/16/24 | received a text message from a resident about a dog being out on the floodwall. It included a picture of the dog. He explained it lived at 425 3rd. When I arrived the dog was out but when I approached it went back into its yard thru the back fence. It did bark aggressively at me. I went around to the front and spoke to a neighbor that said the dog was very aggressive and attacked the mailman once, he had to use pepper spray. I left a Notice for the owner about no tags, running at large and dangerous animal. Owner has fixed the fence and is actively working on the issue.

Thursday 10/17/24 left a Notice at 411 4th for a rottweiler chained up without food or water, per complaint and 2 yorkies that run at large. The owner called back and explained the dog gets food and water in the basement and the Yorkies get out on the daughter and wife and will not listen and come back. He will work on that. The dogs do need their rabies vaccines.

Wednesday 10/23/24 Picked up 2 young kittens that a neighbor found at 1104 5th. One of the kittens can't walk right. Rescue took them!

Thursday 10/24/24 I was able to talk to Parker from 1004 4th and he was willing to pay the vet bill for the injured dog. I will file charges if it does not get paid.
