AN ORDER-RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH TOTAL HOME CARE IN THE AMOUNT OF \$111,300 FOR IMPROVEMENTS TO VARIOUS STRUCTURES LOCATED IN PARKS IN THE CITY OF DAYTON, PAYABLE FROM DAYTON PARK FUNDS.

WHEREAS, residents of and visitors to the City of Dayton, Kentucky ("City") routinely utilize structures and other amenities in the City's seven parks for recreation, events, storage, and security; and

WHEREAS, the city believes it needs to invest in existing buildings and infrastructure in these parks to create a welcoming space for the public to congregate and utilize the recreational opportunities found within these parks; and

WHEREAS, City has identified various park structures in these parks that are subpar, have deferred maintenance, and need to updated and improved; and

WHEREAS, the City's Park Board has reviewed the various structures within these parks and has unanimously recommended that certain structures, including the garage, pavilion, and concession stand at Gil Lynn Park and the pavilion at Sargeant Park, be repaired and improved (collectively "the Project"); and

WHEREAS, the city has advertised and accepted Requests for Bids to construct the Project;

WHEREAS, the City received three separate bids for the Project and City staff has reviewed all these bids and has recommended that the Project be awarded Total Home Care, 634 6th Avenue, Dayton, Kentucky 41074, as the best and most responsive bidder.

NOW, THEREFORE, THE CITY OF DAYTON, KENTUCKY, HEREBY ORDERS AND RESOLVES AS FOLLOWS:

The City Council hereby authorizes the Mayor to enter into a contract and all other appropriate documentation with Total Home Care in the amount of \$111,300.00 for construction of the Project, payable from the Dayton Park Fund. A copy of the bids received from Total Home Care for the Project are attached hereto as Exhibit "A" as if fully written herein and made by reference a part hereof.
