Dayton May Reports 2025

Thursday 5/1/25 Got a message from Cassie to check on a dog at 510 5th. Dog is tied out to the side of the porch on a short leash and no shelter. Left a notice. Dog did have water and is a good weight.

Monday 5/5/25 the dog at 510 5th was loose on the porch and her harness was still chained up to the leash. Got ahold of the owner and she got her in the house. The dog's name is Bear. She claims she don't leave the dog out often, just when she cleans.

Tuesday 5/6/25 Spoke to 918 Maple about his dog getting out and his front gate was open when I arrived. The dog was in the house when I arrived.

Thursday 5/8/25 left a card at 1021 5th. The odor coming from the house smells like dog, not dead animals. The daughter called me right away. I told her I needed her mom to take the dogs to the vet and get a rabies vaccine and exam.

Got a call about a cat on the roof at 415 8th. There were workers on the roof and no cat. I found the cat at 417 8th and left a notice on their front door. I did get ahold of the owner of the property and he does not own a cat and has no idea how the cat got there. With the help of the fire department we got the cat down. He was a neutered male. I posted him on facebook to find an owner, no one came forward so the shelter recommended I release him back in the neighborhood.

Monday 5/12/25 I was off today and this morning got a call about 2 dogs on Brooklyn. I told dispatch they probably live at 627. Tony Balwin called me and they did live there but no one was coming to the door. I gave him Troy Coleman's number and he didn't answer. I was starting that way when Tony called me back and disregarded me they got the dogs in the house.

I got a call from Chief Halfhill about the dog Webbie being on his street at his neighbors house. I gave him the owner's phone number.

Wednesday 5/14/25 TNR female cat from 409 Kenton. Cat was pregnant.

TNR injured cat from 316 9th. OAR recommended the cat see a full service vet. Petwow seen the cat and gave a long acting antibiotic shot and topical meds and said to watch the area. The feeder is going to keep the cat inside until it heals. Cat is very friendly.

TNR male cat from 804 6th.

Thursday 5/15/25 Tried to check on Shadow at 627 Brooklyn they spoke to me thru the door and said come back in a few hours. When I returned they were gone. I spoke to them on the phone and she claimed Shadow has gained weight. I need to see him to close out my case.

Friday 5/16/25 Called out by the fire dept. for a dog they found. When I arrived at the fire dept. they had already found the owner.

Monday 5/19/25 Spoke to 510 5th about Bear still being on a short leash. That is the only place they can leave her, if they add length to the leash she may fall or jump off the wall and hang herself. She did have food and water when I arrived. She is also current on vaccines. I took a picture of the vet records.

I left information and my business card at 1212 Dayton ave about feeding cats and not attracting wildlife. I did speak to the resident and advised him of the information I left on his door. I did offer to TNR the cats also.

Tuesday 5/20/25 Picked up 2 dogs from a porch at 1208 4th. The dogs belong to Christy Bruce at 1002 3rd. I called her and she was walking to the court house to get a restraining order on her husband. He hit her and kicked her and the dogs out of the house. I called the shelter to see if I could bring them there and they said no. I had to take the dogs back to Christy, who I met at 6th and Vine and I texted her temporary housing for pets information.

Tuesday 5/27/25 Spoke to 206 5th about his roommate Shane allowing the dogs to run loose and charge at the neighbors fence line. He also was on video raising a stick up to hit the husky that lives there. Resident said he would talk to him.

Did a welfare check on Shadow at 627 Brooklyn. Owner, Troy Coleman brought Shadow out and he is still very thin. He pulled him away from me and put him back in the house then came out to talk to me. He said he had no food and his wife is in jail. He heard the dogs fighting inside. He went back in the house and was yelling for help. I called the police. Troy threw a dog out of the house that had an injury to his ear from the dog fight, his name was Buddy. He also said they tried to kill Shadow. Officer Wiley was first on the scene and I told him what happened and that I needed to check Shadow. He brought Shadow back out and he had multiple bite wounds on his head. Troy also had a couple warrants and was arrested. He has a total of 5 dogs. I put Buddy and Shadow in the van for medical treatment and asked Troy if he had anyone that could watch the other 3 dogs while he was gone. He was able to get his daughter to care for the other dogs. I got her number and was in contact with her. The vet treated both dogs and Buddy was taken back home and Shadow was taken to the shelter for an evidence hold for cruelty charges.

Wednesday 5/28/25 TNR male cat from 332 9th.

TNR female cat in heat at 610 Main.

APPROVED/ONGOING PROJECTS	
TANK Grant	Jerrold is working on updating the cost estimate for the modified scope. Once we submit to KYTC we will be authorized to get bids for construction.
Velo Apartments	Public Works to remove the existing sidewalk ahead of the new path being installed as part of Riverfront Commons Phases II and II. The owners will be assessed for the cost.
6-453 Dayton Riverfront Commons Ph 2 and 3 12' wide concrete bicycle/pedestrian trail and conduit for future lighting from Berry Street to Fourth Avenue. [Designer is KZF]	Everything has been approved by District 6 and they have sent the request to KYTC central office to authorize the construction funds so the project can be put out to bid.
6-3228 Dayton Pike Sidewalk Connector (Ph 2) New 1500' of 5' sidewalk along west side of Dayton Pike	NKWD is installing a new water main through this area that will replace the 2 existing mains. They anticipate the water main project will begin in August and last 2 months. The goal is for PRIME AE to have the plans ready to go to construction as soon as the water main project is completed. PRIME is working on getting us the areas where the work extends beyond the right of way so we can go door to door to get consent and release forms signed.
Upper Riverfront Commons Trail Improvements Improve the existing trail at the top of the earthen levee that runs along the south side of Manhattan Boulevard	The project will be re-submitted to OKI for consideration the first week of June.
Grant Park Drive Stormwater Mitigation Project	Work has been completed and after a heavy rain, the area where the work was done was the only section of roadway with dry gutter lines. We are working to get the as built plans submitted and the reimbursement from SD1 for their portion of the work.

7th Street Slide	Recived \$70,000 in funding to put toward the 7th Street Slide geotechnical exploration and engineering design. Design is complete and we have a cost estimate for construction. We need to submit for additional funding for construction. We are looking into the possibility of using CDBG funding for the retaining wall.
Third and Walnut Stormwater Mitigation Project	Design work has been completed and the 50-50 application has been submitted to SD1. They are reviewing and we are waiting on final approvals. The project was supposed to go to the SD1 boad for consideration at the May board meeting. There is a chance they will pay for more than 50%. We are waiting to hear back from SD1 on the status.
Riverpointe Stormwater Improvements	The 50-50 cost share application has been submitted to SD1 for consideration. We are waiting to hear back on whether the project was approved for funding.
2025 Resurfacing	Roadway list has been finalized. We have a cost from Hendy to reconstruct all the curb ramps within the paving areas to meet ADA requirements. Project is ready to be advertised in conjunction with Bellevue.

FIRE & EMS Report:

Response calls: We made 127 EMS calls and 50 fire calls for a total of 177 responses

Training: We have an average of 68.43 training hours per member. This month topics included Solar panels, forceable entry, pump ops, attack lines, ladders, endocrinology, ambulance safety, and drivers training

FIRE INSPECTIONS: We performed 6 annual inspections

BURN PERMITS: Burn ban in effect until October

PUBLIC ACTIVITIES AND EVENTS: St Elizabeth came in for blood draws for our annual physicals. We taught CPR for 94 students at Dayton Schools.
