



## CITY OF DAYTON

Regular Council Meeting Minutes  
May 13, 2025

Dayton City Council held a Regular Council meeting on Tuesday, May 13, 2025, at 7:00 p.m. at the Dayton Community Center, 625 Second Avenue.

City Clerk Tristan Klein delivered the roll call. Members present were Member Kelly, Member Judd, Member Lovins, Member Horton, Member Neary, Member Nyman, City Administrator Fossett, City Attorney Alex Edmondson, and Mayor Baker.

Mayor Baker opened the meeting with a moment of silence and the Pledge of Allegiance.

**Mayor's Report:** Mayor Baker reminded everyone about the upcoming Memorial Day Parade

### **Minutes:**

A motion was made by Member Judd to approve the April 8, 2025, City Council Minutes. Motion seconded by Member Horton. All Members voted aye to approve the minutes.

### **City Administrator Fossett:**

City Administrator Fossett presented information regarding the 7<sup>th</sup> Street Slide to the City Council and Senator Shelley Funke Frommeyer and Representative Matthew Lehman and asked that the Senator and Representative keep the project in mind as they enter the next legislative session.

### **Senator Funke Frommeyer and Representative Matthew Lehman:**

Both Senator Funke Frommeyer and Representative Matthew Lehman addressed the City Council about the progress made in the previous legislative session and asked for a continued open dialogue about the issues impacting Dayton.

### **Presentation and discussion regarding response to Dayton-Bellevue Solid Waste and Recycling RFP:**

City Administrator Fossett, Bellevue City Administrator Warnock, and Rumpke Representative Robin Klaber addressed the City Council about the Rumpke response to the Solid Waste and Recycling RFP, which was the only response that Dayton received. No action was taken.

### **Ordinances:**

**First Reading: Ordinance 2025-1:** An Ordinance adopting the City of Dayton, Kentucky's annual budget for the fiscal year running from July 1, 2025 through June 30, 2026, and estimating revenues and resources and appropriating funds for the City to the full extent authorized by KRS 82.082 and interpretative case law.

Ordinance 2025-1 was read for first reading.

**First Reading: Ordinance 2025-2:** An Ordinance amending Chapter 95 of the City of Dayton, Kentucky, Code of Ordinances ("Code") to add a new section prohibiting the use of motorized vehicles in Sargeant Park other than in the parking areas of the park, including a criminal penalty for failure to comply with this code section.

Ordinance 2025-2 was read for first reading.



**Orders/Resolutions:**

**Order Resolution 2025-8R:** An Order-Resolution of the City Council of the City of Dayton, Kentucky, appointing individuals to various City boards and commissions.
